**The Award:** a certificate and medal, gold color and green cloisonné, to be presented at the 2010 NW&P Region Conference in Eugene, Oregon on October 13-16.

**The Eligibility Requirements:** the nominee must be an AIA member in good standing who is assigned to a component in the AIA Northwest & Pacific Region.

**The Deadline:** nominations must be received by 5:00 p.m., August 30, 2010 (Monday)
